3. Updates from Staff

The staff is currently working on finishing the CAFR. The Mid-Year Report will be presented to Council after the CAFR is done. Sharif Etman will be meeting with the CalPERS actuary the week of Jan 27<sup>th</sup>. The 10 Year Plan will be presented to Council before April 2020 to provide Council with more information about the fiscal impact of recent Council decisions.

# 4. Discussion of Financing Options for Community Center

Given the current financial situation, the City of Los Altos will have to borrow additional funds for the construction of the new Community Center. The council recommended to the developers of 5150 El Camino Real that they should build a park instead of providing the City with park-in-lieu funds. Since park-in-lieu funds are no longer available for the Community Center, we will be pursuing bank loans to finance our new Community Center. Commissioner Martin will be



spearheading the search for a loan for the new Community Center. He announced that if any commissioners have contacts to banks they can reach out to him.

#### 5. Discussion of Legal Costs and Fiscal Impacts

Over the month of December 2019, it has become clear that there are 10 pending lawsuits and litigation against the City. The City is facing more lawsuits than ever before.

Chair Kalkat will send an email to the Council on behalf of the Finance Commission regarding their discontent with the current financial positioning of the City. He also expressed the need for Council to have more accountability and consideration for the overall fiscal impact of their Council meeting decisions on the City.
