## 2. <u>12-H-03 – D and M. Beumer – 452 University Avenue</u>

The applicant's historical consultant presented the application, noting that the structure was also eligible for listing on the State and National Register of Historic Places.

MOTION by Commissioner MARFATIA, seconded by Commissioner AHMADJIAN-BAER, to recommend that the City Council designate the property at 452 University Avenue as a Historic Landmark.

### 3. 13-H-01 – J. Geleynse – 1448 Fowler Lane

The property owner presented the application. Staff Liaison DAHL noted that the property appeared eligible for designation as a Historic Resource or as a Historic Landmark

The Commission expressed support for designating the property as a historic landmark as a rare example of a Dutch Colonial Farmhouse and as a contributor to the City's early agricultural development context.

MOTION by Commissioner WELSH, seconded by Commissioner MARFATIA, to designate the property at 1448 Fowler Lane as a Historic Resource.
