3. <u>Commission Minutes</u>

MOTION by Commissioner BAKER, seconded by Commissioner MARFATIA, to approve the February 25, 2013 regular meeting minutes.

4. <u>13-H-02 – H. Akhavein – 11 Angela Drive</u>

Staff Liaison DAHL presented the staff report, recommending that the Commission recommend approval of a minor alteration to an existing Historic Resource structure. The project architect spoke in support of the project and answered questions from the Commission.

The Commission expressed general support for the proposed project.

MOTION by Commissioner WELSH, seconded by Commissioner BAKER, to recommend approval of the minor alteration to the Historic Resource at 11 Angela Drive.

5. <u>Historic Preservation Award</u>

Staff Liaison DAHL presented the staff report, noting that no nominations for the award had been submitted yet.

The Commission discussed ways to provide additional outreach to ensure that the public was aware of the award.

6. <u>FY 2013/14 – 2017/18 Capitol Improvement Program</u>

Staff Liaison DAHL presented the Commission with the City's five-year Capitol Improvement Program, noting that the Council was seeking input from all Commissions on CIP projects.

The Commission reviewed the five-year Capitol Improvement Program, noting that there were not any projects that appeared to fall within the purview of the Historical Commission. The Commission noted that there was not a CIP related to the Halsey House.

MOTION by Commissioner CHAPMAN, seconded by Commissioner MARFATIA, to recommend approval City's five-year Capitol Improvement Program as proposed, with the following recommendation:

• Add the restoration and adaptive reuse of the Halsey House as a new project to the Capitol Improvement Program.

7. <u>Commission Goals and Work Plan</u>

Staff Liaison DAHL presented the Commission with a draft 2013 Work Plan.

The Commission accepted the work plan as proposed, but noted that they would like to see a Historical Commission yearly calendar developed that identified critical dates and deadline for things like the Margaret Thompson Essay Contest and Historic Preservation Award. The Commission also noted that implementation of the Historic Plaque Program should be a priority.
