Residents Seifert and Brown recommended using consistent language in paragraph J of Section 12.44.080 to require that an application is defined as "complete" when the City Council has "approved the historic district boundary."

<u>Action</u>: Upon a motion by Commissioner Lang, seconded by Commissioner Bartlett, the Commission recommends approval of amendments to Chapter 12.44 of the Los Altos Municipal Code with direction to bring the code into alignment with the single-story overly district process, with a provision that staff and the City Council may modify the code to address legal compliance requirements.
