1. Commission Minutes

2. 14-H-07 – J. Geleynse – 1448 Fowler Lane

Senior Planner DAHL presented the staff report.

Owner John Geleynse presented the project, noting that the goal was to reuse as much of the existing railing as possible. Architect Chris Grasso noted that two different color tones would be used to differentiate old versus new elements. There was no other public comment.
