1. Commission Minutes

2. Financing a New Library

Coalition made up of 2 entities – Members of Friends of the Library and Los Altos Library Endowment are still in early stages of locating private or mostly private resources to help fund a new library. The group meets on Friday mornings. Commissioner Bhagavan will provide the group with information regarding how Dover public library secured funds for a new library.

3. <u>Directional Signage for Woodland Library</u>

Staff reported on placement of new reflective signs to be installed near Woodland Library. Commissioners had concerns that the intended placement was not suitable. Staff will work with the City's Street Supervisor to prepare a more suitable location for the sign to be installed. Commissioner Bhagavan offered to meet staff at Woodland Library to review appropriate locations.

4. Youth Commission Update

Teen Librarian, Sarah Leeri, Commissioners Hill and Bhagavan will attend the April 13th Youth Commission meeting to follow up on ideas for teen needs in the Library. Also, the Library has reserved the Program Room of the Library for High School students to use two weeks prior to finals for study and preparation purposes.

5. Parking at Los Altos Main Library

Discussed parking issues at Main Library on County Holiday when the library was closed. A portion of the parking lot was full. City police cannot enforce parking violations in the lot unless violators park in appropriately marked disabled parking spaces.

6. Work Plan for 2015

Commissioners planned to meet on April 28th to finalize the Commission's work plan for 2015. Commissioner Struthers will also give an overview to the Commission of all the agencies that support the Library.
