ROLL CALL

PLEDGE OF ALLEGIANCE

Mayor Satterlee led the pledge of allegiance to the flag.

PUBLIC COMMENTS

Kurt Ayers, Los Altos resident, requested additional funding for traffic enforcement in Los Altos.

Jitze Couperus, Los Altos Hills resident, announced the completion of the Adobe Creek Upper Reach Five Project.

CONSENT CALENDAR

On a motion by Councilmember Carpenter, seconded by Councilmember Becker, and passed unanimously, the following items were approved:

PUBLIC HEARING

Assistant City Manager Walgren summarized the recommended allocations and noted that one applicant was not recommended because an aspect of their reporting does not meet the county's criteria.

Mayor Satterlee opened the public hearing and the following offered comments: Maureen Wadiak, representing Community Services Agency David Duram, representing Support Network for Battered Women Jennifer Burkett, representing Long Term Care Ombudsman

Mayor Satterlee closed the public hearing and invited additional speakers to attend the second public hearing on March 10, 2009.

DISCUSSION ITEMS

8. Community Center Master Plan

Councilmember Packard recused himself due to a financial interest he holds in property within 500

Assistant City Manager Walgren presented a brief report.

Pamela Anderson Brule' and Monique Wood, architectural consultants, opened the presentation with an overview of the progress to date, a scenario overview, moved to specific details for each of the three scenarios, reviewed fourteen design drivers, cost modeling and concluded with general comments.

At this juncture, Mayor Satterlee recessed the meeting for 10 minutes and then reconvened at 8:25 p.m.

The consultants responded to questions posed by Council relative to phasing, location of components of the site, maximizing the use of available acreage and moving some programs to alternative sites. Council focused their discussion on building on the preferred scenario 3, being sensitive to the potential traffic, noise and luminary impacts on adjacent residents.

Council took the following actions relative to the development of Scenario No. 3:

1. Motion by Councilmember Carpenter, seconded by Councilmember Becker, to include two pools and a water play feature on the site. The motion carried unanimously.

- Motion by Mayor Satterlee, seconded by Councilmember Carpenter to exclude a skate park from the site. The motion carried unanimously.
- Motion by Councilmember Becker, seconded by Councilmember Carpenter, to direct the Parks,
 Arts and Recreation Commission to investigate alternative locations for a skate park. The
 motion carried unanimously.
- 4. Motion by Mayor Satterlee, seconded by Councilmember Carpenter, to leave the baseball field at its current location. The motion carried unanimously.

(This motion was overturned later in the meeting; see motion number 8.)

- Motion by Mayor Satterlee, seconded by Councilmember Carpenter, to leave the soccer field as shown on scenario 3, with some flexibility. The motion carried 2-1, with Councilmember Becker dissenting.
- 6. Motion by Mayor Satterlee, seconded by Councilmember Becker, to leave the Neutra House at its existing location. The motion carried unanimously.
- 7. Motion by Mayor Satterlee, seconded by Councilmember Becker, that it is highly desirable to have some parking adjacent to the Neutra House. The motion carried unanimously.
- 8. Motion by Mayor Satterlee, seconded by Councilmember Becker, to leave the 95 parking spaces, that are located at the current baseball field location, locate the baseball field on Hillview Avenue, with flexibility, as shown on scenario no. 3. This action nullifies action number 4.
- 9. Motion by Councilmember Becker, seconded by Councilmember Carpenter, to show the placement of the theater as a dotted line to indicate possible location on scenario 3, and direct the Parks, Arts and Recreation Commission to consider putting the theater at Village Park. The motion carried unanimously.
- 10. Motion by Councilmember Carpenter, seconded by Mayor Satterlee, that the architects may use their discretion on placement of elements along Hillview Avenue. The motion carried unanimously.
- 11. Motion by Mayor Satterlee, seconded by Councilmember Carpenter, to accept the parking assumptions presented by the architects. The motion carried unanimously.
- 12. Motion by Mayor Satterlee, seconded by Councilmember Becker, to maintain all surface parking. The motion carried unanimously.
- 13. Motion by Councilmember Carpenter to maintain a half-acre area for an orchard, noting that apricot trees are preferred, and other flowering trees, along San Antonio Road and the entryway into the site. The motion carried unanimously.
- 14. Motion by Mayor Satterlee, seconded by Councilmember Becker, to limit the number of driveways on Hillview Avenue to two. The motion carried unanimously.
- 15. Motion by Mayor Satterlee, seconded by Councilmember Carpenter, that the bocce courts be located adjacent to the senior lounge area. The motion carried unanimously.
- 16. Motion by Mayor Satterlee, seconded by Councilmember Carpenter, to have flexibility to examine basement schemes. The motion carried unanimously.

17. Motion by Councilmember Carpenter, seconded by Councilmember Becker, that scenario 3 is preferred. The motion carried unanimously.

Council discussed the library and agreed that the decision for either a new or remodeled building lies with the Library and that either scheme can fit in the preferred scenario. They briefly discussed options for Children's Corner.

Pamela Anderson, project architect, noted the next steps and upcoming meeting schedules. There was interest in holding additional community outreach meetings prior to Council taking action on April 28, 2009.

Council direction was given for the Master Plan Advisory Committee to develop an outreach plan and report back to Council by March 24, 2009.

Councilmember Packard returned to the dais.

COUNCIL REPORTS AND DIRECTIONS ON FUTURE AGENDA ITEMS

Mayor Satterlee reported that at the December 9, 2008 closed session, Council formed a subcommittee to study the records related to the purchase of the Los Altos sewer treatment site. The subcommittee included Mayor Satterlee and Councilmember Packard.

City Manager Schmitz reported that the bridge behind West Valley Elementary School is finished and open. He suggested that in addition to the Parks, Art and Recreation Commission, the Youth Commission also consider locations for the skate park. Council concurred.

Councilmember Becker reported on a Water Board meeting where potential water rationing was discussed. He requested an agenda item to discuss a joint use agreement for community facilities with Los Altos Hills. Councilmember Carpenter agreed to support pending a letter of interest from Los Altos Hills.

Councilmember Carpenter requested an agenda item for discussion regarding the Halsey House, located at 284 University Avenue, at either the joint City Council-Historical Commission meeting or the regular Council meeting on February 24, 2009. Councilmember Packard supported. She requested a meeting with the Master Plan Finance subcommittee. In conclusion, she requested that council discuss options for Children's Corner. Councilmember Becker supported.

Councilmember Packard distributed the "Report of Findings on the Source of Funds to Acquire Sewer Plant Site" and requested to agendize the matter to be heard at two council meetings to discuss subcommittee report for February 24, 2009 to hear public comment and to hear additional comment and take action on March 10, 2009. Mayor Satterlee and Councilmember Carpenter supported.

ADJOURNMENT

Mayor Satterlee adjourned the meeting at 10:12 p.m.
