WHEREAS, at the Special Election, residents were asked to vote on Measures G, H, and I, the titles of which appear on Exhibit "A" attached; and

WHEREAS, pursuant to State Elections Code Section 15400, the City is required to accept the Statement of Election Results and declare the totals to be final results of the election;

NOW, THEREFORE, BE IT RESOLVED, by the City Council of the City of Los Altos that:

1. The City Clerk of the City of Los Altos is hereby instructed to enter this resolution into the minutes of the Los Altos City Council as a true statement of the results of said elections; and
2. The Los Altos City Council hereby accepts the Certified Statement of November 2, 1999 Election Results by the Santa Clara County Registrar of Voters (attached as Exhibit "A");

G Shall Ordinance 99-370 of the City of Los Altos, providing for term limits for Los Altos City Councilmembers, be approved?

H Advisory Vote Only. COMMUNITY IMPROVEMENT ADVISOAY VOTE. City of Los Altos voters request that utility users tax increases above $3.5 \%$ be appropriated by City Council (with citizens' watchdog committee advice) for service improvements in:
Maintenance

- Critical deferred facility repairs and preventive maintenance
- Crack-sealing, street maintenance
- Street landscaping maintenance

Recreation

- Facility acquisition and construction
- Park land acquisition
- After-school youth program

Public Safety

- Emergency (9-1-1) communications
- Continue and expand traffic safety program
- Traffic engineering assistance

I Shall the City Council of the City of Los Altos be authorized, annually, to set the rate of any utility users tax of the City at a rate not to exceed $6.25 \%$ ?

That the official canvass of the returns of said election was conducted by the Office of the Registrar of Voters in accordance with the appropriate provisions of the Elections Code of the State of California; and

That the Statement of Votes Cast, hereto attached, shows the whole number of votes cast for each candidate for said Councll Seats, and for and against Measures G, H and I in the City of Los Altos, and in each of the respective precincts; and that the totals shown for each candidate are true and correct.
