A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LOS ALTOS AUTHORIZING THE SUBMITTAL OF PROPOSALS FOR NON-COMPETITIVE FUNDS FROM SANTA CLARA COUNTY UNDER THE FEDERAL HOUSING AND COMMUNITY DEVELOPMENT ACT FOR FISCAL YEAR 2002/2003

WHEREAS, the City of Los Altos has previously entered into a Joint Powers Agreement with Santa Clara County to form an Urban County under the Housing and Community Development Act; and

WHEREAS, the City Council held duly noticed public hearings on February 26, 2002 and March 26, 2002 on the allocation of funds under the Community Development Act; and

WHEREAS, the City Council finds and determines that the following proposals represent the community development needs in Los Altos;

NOW THEREFORE, BE IT RESOLVED, that staff is hereby authorized to submit proposals for the expenditures of CDBG funds in the amount of \$175,046 as described below:

BE IT FURTHER RESOLVED THAT the final 2002/2003 CDBG funding allocations are provisioned as follows:

- 1) That the City's CDBG program is fully funded by the federal government; and
- 2) That any unspent capital project funding shall be returned to the City.
- 3) Payment of the funds allocated to the Saint Joseph the Worker Center shall be contingent upon the reopening of a local day worker center in the Los Altos Mountain View area by December 31, 2002.

BE IT FURTHER RESOLVED THAT the County is authorized to make a \$10,000 grant (maximum of four per year) for lead-based inspection and abatement expenses for each CDBG housing rehabilitation loan project in the City from the Housing Rehabilitation Loan Fund.

BE IT FURTHER RESOLVED THAT the City Manager is hereby authorized to execute standard CDBG contracts between the City and the non-profit agencies for Fiscal Year 2002/2003.
