**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LOS ALTOS
DECLARING CANVASS OF RETURNS AND RESULTS OF THE GENERAL
MUNICIPAL ELECTION HELD ON NOVEMBER 4, 2003**

WHEREAS, the City Council of the City of Los Altos duly called and ordered held in the City on Tuesday, November 4, 2003, a General Municipal Election pursuant to Section 10400-10418 of the California Elections Code, to fill three seats; and

WHEREAS, pursuant to the applicable provisions of the Elections Code of the State of California, the Registrar of Voters of the County of Santa Clara has duly canvassed the votes cast by the electors in the City of Los Altos upon the offices hereinafter set forth, and has certified to the City Council the results of the votes cast, which certification is attached as Exhibit "A" and incorporated by reference;

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LOS ALTOS THAT:

1. The canvass by the Registrar of Voters as shown in Exhibit "A" and the results of the votes cast at the General Municipal Election is hereby ratified, confirmed and approved.
2. The total numbers of votes cast in the City of Los Altos at the General Election, and the number of votes cast in each precinct for the persons and respective offices to be filled at the General Municipal Election is set forth in Exhibit "A." All absent voters' ballots have been duly received and canvassed in time, form and manner as required by law, and the results of the absentee vote are set forth in Exhibit "A."
3. The names of the persons voted for the offices of Councilmember and the total number of votes (including absentee votes) given in the City to each of the persons were as follows:



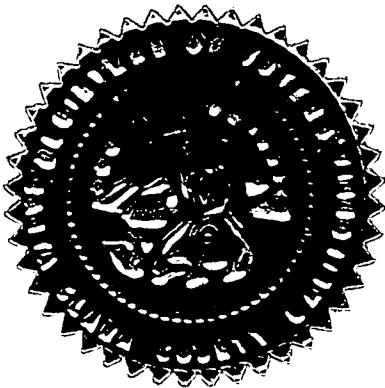
The official canvass of the returns of said election was conducted by the Office of the Registrar of Voters in accordance with the appropriate provisions of the Elections Code of the State of California.
