A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF LOS ALTOS ORDERING THE VACATION OF A CERTAIN STRIP OF LAND DESIGNATED AS A PUBLIC RIGHT OF WAY BY THE "TRACT NO. 24 WASSON SUBDIVISION" FILED JUNE 27, 1932, IN BOOK 1 PAGE 4&5, RECORDS OF SANTA CLARA COUNTY CALIFORNIA.

WHEREAS, pursuant to the provisions of Chapter 4 of the California Streets and Highway Code, Section 8334 *et seq.*, the City Council may summarily vacate "an excess right-of-way of a street or highway not required for street or highway purposes"; and

WHEREAS, the public right-of-way by Tract No. 24 Wasson Subdivision filed June 27, 1932, in Book 1 Page 4&5, Records of Santa Clara County California (said Tract No 24 is attached hereto as Exhibit "A"); and

WHEREAS, the City Council having duly considered all evidence, and followed the procedure prescribed by law, hereby finds and determines from all evidence submitted that the proposed order of vacation of the public service easement conforms with the provisions of Section 8334 of the California Streets and Highway Code.

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF LOS ALTOS AS FOLLOWS:

1. That the portion of public right-of-way by the Tract No. 24 filed June 27, 1932, in

Book 1 Page 4&5, Records of Santa Clara County California, is now no longer necessary because it has not been used for the purpose for which it was dedicated for five (5) consecutive years immediately preceding the proposed vacation, and there are no other public facilities located within the easement.

2. That the City Council, pursuant to Streets and Highway Code, Chapter 4, Section 8334 *et seq.*, hereby orders the vacation of the public right-of-way described in Exhibit "A" attached hereto; and

3. This Resolution shall become effective on the 22<sup>nd</sup> day of August, 2017, and shall be recorded by the City Clerk in the Santa Clara County Recorder's Office shortly thereafter; and

4. 



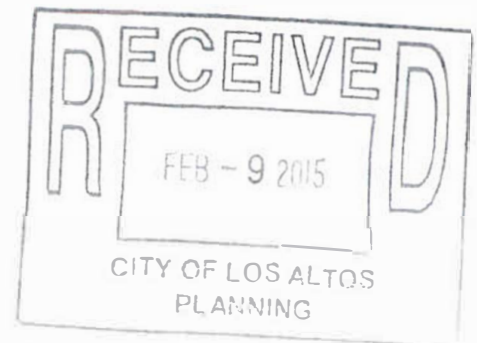

**Exhibit "A"**  
**Legal Description for Lot Line Adjustment**  
**Parcel 1**  
**Los Altos, California**

All that certain real property situate in the City of Los Altos, County of Santa Clara, State of California, being all of the lands of Huang and Siuling as described in that certain Grant Deed recorded June 17, 2013 in Document No. 22266528, Santa Clara County Records and a portion of Van Buren Place as shown on that certain map entitled, "Tract No. 24 Wasson Subdivision" filed in Book 1 of Maps at Pages 4 and 5, Santa Clara County Records. Said lands are shown on attached plat Exhibit "B" and made a part hereof, more particularly described as follows:

**Beginning** at the most Southeastern corner of Lot 8, in Block 2 as shown on said map; thence along the Southerly line of said lot North 89°59'00" West, 181.46 feet to the centerline of Adobe Creek; thence along said centerline the following twenty (20) courses:

2. North 18°37'05" West, 54.17 feet
3. North 34°48'00" West, 12.08 feet

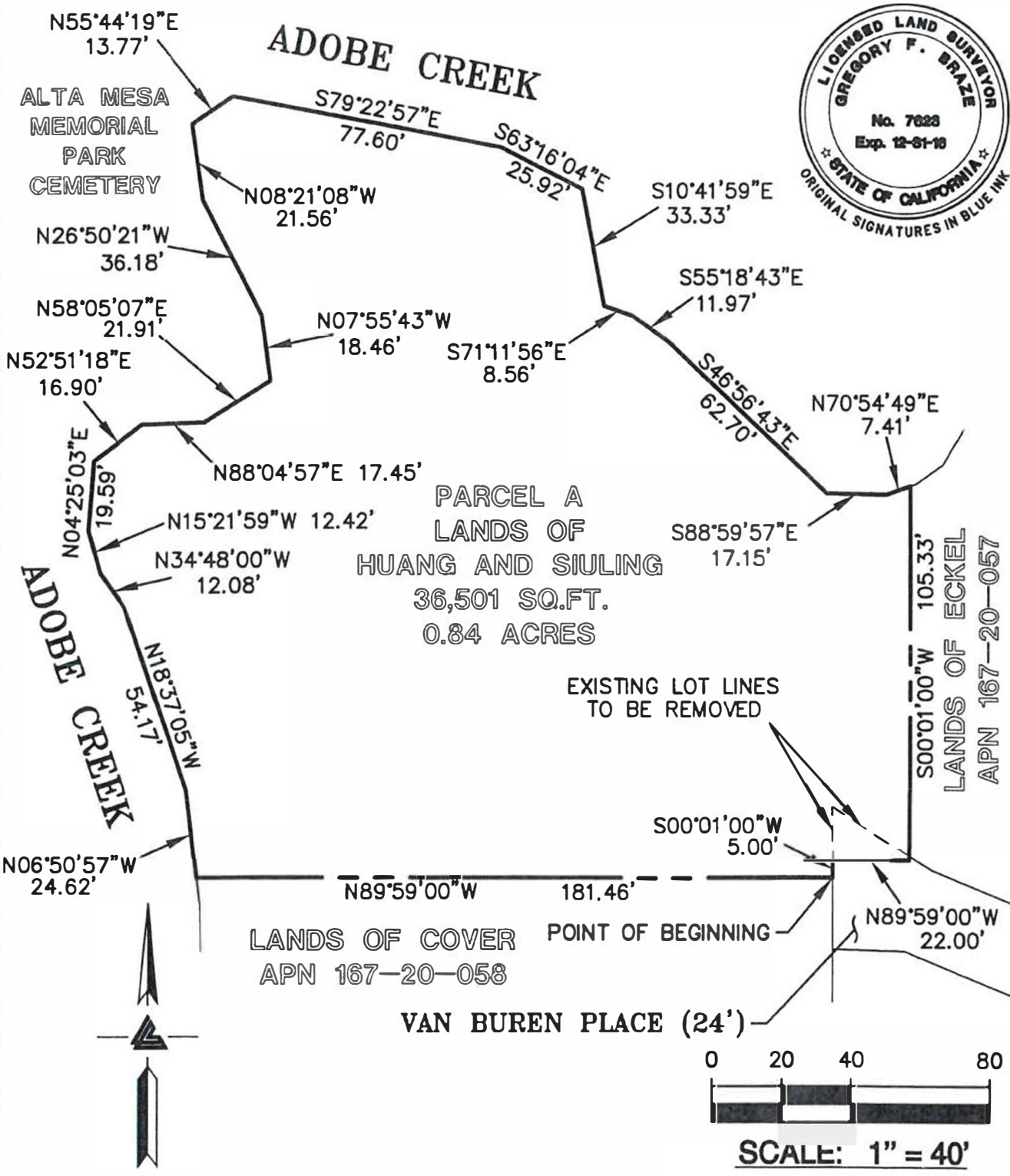
