ORDINANCE NO. 2014-400

AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF LOS ALTOS AMENDING CHAPTER 14.88 OF THE LOS ALTOS MUNICIPAL CODE PERTAINING TO REZONING 448 SOUTH SAN ANTONIO ROAD AND A PORTION OF PUBLIC ALLEY ADJACENT TO SAN ANTONIO ROAD FROM CD AND RIGHT-OF-WAY TO CD/R3

WHEREAS, the owners of the properties at 448 South San Antonio Road, 470 South San Antonio Road and 467 First Street initiated an application (13-Z-01) to amend the Zoning Designation on the property at 448 South San Antonio Road and an adjacent portion of public alley from the Commercial Downtown (CD) District and right-of-way to the Commercial Downtown/Multiple-Family (CD/R3) District, referred herein as the "Z"; and

WHEREAS, said Z is in the best interest for the protection or promotion of the public health, safety, comfort, convenience, prosperity, and welfare, and is consistent with the adopted General Plan of the City; and

WHEREAS, said Z was the subject of an environmental initial study and mitigated negative declaration, prepared by the City as the lead agency in compliance with the requirements of the California Environmental Quality Act of 1970 as amended ("CEQA"); and

WHEREAS, required public notices and public hearings were duly given and duly held according to law; and

WHEREAS, the Planning and Transportation Commission held a duly noticed public hearing on the Z on January 23, 2014 and the City Council held a duly noticed public hearing on the Z on March 11, 2014; and

WHEREAS, the Z was processed in accordance with the applicable provisions of the California Government Code and the Los Altos Municipal Code; and

WHEREAS, the location and custodian of the documents or other materials which constitute the record of proceedings upon the City Council's decision is based in the Office of the City Clerk.

NOW THEREFORE, the City Council of the City of Los Altos does hereby ordain as follows:

SECTION 1. AMENDMENT OF CODE: Section 14.88.680 entitled "Zoning map amended" is hereby added to Chapter 14.88 of Title 14 of the Los Altos Municipal Code to read as follows:

Zoning map amended.

The properties generally referred to as 448 South San Antonio Road (APNs 167-41-057 and 167-41-058) and a portion of adjacent public alley right-of-way as delineated on Rezoning Map No. 13-Z-01, attached hereto and incorporated herein by reference, are hereby included within the Commercial Downtown/Multiple-Family (CD/R3) zoning district.

SECTION 2. FINDINGS. The City Council finds in accordance with Chapter 14.86 of the Los Altos Municipal Code that the amendment is in the best interest of the City for the protection

and/or promotion of the public health, safety, comfort, convenience, prosperity, and welfare; and that the amendment is in conformance with the City of Los Altos General Plan.

SECTION 3. CONSTITUTIONALITY. If any section, subsection, sentence, clause or phrase of this code is for any reason held to be invalid or unconstitutional, such decision shall not affect the validity of the remaining portions of this code.

SECTION 4. PUBLICATION. This ordinance shall be published as provided in Government Code section 36933.

SECTION 5. EFFECTIVE DATE. This ordinance shall be effective upon the commencement of the thirty-first day following the adoption date.


