3. Fields and courts are closed annually for maintenance. No permits will be issued for the time periods in which they are closed.
4. It is the City of Los Altos Recreation Department's policy to leave one court open at each site for public use.
5. The Los Altos High School tennis courts are reserved through the Mountain View/Los Altos Union High School District.
6. It is your responsibility to leave the facility clean.
7. Restrooms: Public restrooms are open at McKenzie, Rosita & Marymeade Parks as well as Hillview and Grant Park for your convenience. Please monitor your groups restrooms use during and after your event and clean-up as needed.
8. Rental fee is based on total hours of all practices and games multiplied by the hourly rate.
9. Payments by credit card or check are accepted. Checks payable to "City of Los Altos".

10. Refunds will not be granted for any cancellations of tennis court reservations. Reservations are non-transferable.
