Public comment from Phyllis Baer, 1 W Edith Ave

The preliminary findings of the Parks Needs Assessment telephone survey conducted by Godbe Research and the park use focus groups facilitated by Royston, Hanamoto, Alley & Abey were presented by Brian Godbe, Cordelia Hill and Tara McIntyre. Suggestions for follow up by the Commission were: find comparative cities in geographical size & population; locate the "tri-city sports league" for input on field usage; list the school site acreage totals; hold an open house specifically for south Los Altos; itemize themes and topics that repeatedly show up; add more color; extract the under 18 year old types of activities and frequency from within the Godbe data. Commissioners requested that the next progress meeting by held as a study session separate from the regular PARC meeting. No action was taken.

4. <u>Dancing Man Sculpture</u>

Concerns about setting a precedence by purchasing a previously owned sculpture were raised. Substitute motion to extend the loan for another year while considering purchase next fiscal year was suggested and tabled for discussion in October.
