OFF-LEASH AREA (OLA) RULES

Please abide by the following rules so everyone can enjoy this facility:

- Leash all dogs unless in the designated off-leash area.
- Owner is responsible for the dog's behavior and any damage caused by the dog.
- No person shall have more than two(2) dogs in a posted off-leash area at one time.
- "Field Closed" areas include people and dogs.
- Dogs must be watched at all times.
- Dogs must be under voice control at all times.
- Poop happens...when it does, pick it up.
- All dog bites must be reported immediately to Silicon Valley Animal Control Authority (SVACA) at (408) 764-0344.



OFF-LEASH DOG AREA RULES



HELP MAKE THIS AREA FUN AND SAFE FOR ALL

- All dogs to be accompanied by and under control of their owner.
- Off-leash use permitted within fenced area only.
- Vicious dogs are not permitted within the fenced area.
- Aggressive dogs must be muzzled. Any dog showing aggressive behaviour must be removed from the area.
- If your dog digs a hole, please fill it in.
- Pick-up after your dog. No one likes surprises underfoot.
- No smoking in, or within 15 meters of, fenced area.
- Respect your neighbourhood. Please limit excessive barking.
- Report any site maintenance issues to 604-526-4691.

Dog Play Area Rules and Regulations

- Pets, other than dogs, are not permitted.
- Only activities common and customary for playing with, training and exercising dogs are allowed. No other uses, including park uses and commercial uses, are allowed.

The following dogs are not permitted in the dog play area:

- Aggressive dogs and dogs with a known propensity or disposition to attack, bite or otherwise endanger the safety of humans or other dogs. Any dog that acts aggressively towards people or other dogs shall be immediately removed from the dog play area.
- Female dogs currently in estrus.
- Dogs that do not have current rabies vaccination tags issued to the particular dog, which tags must be attached to the dog's collar or harness.

The following restrictions shall apply to persons within the dog play area:

- A person ten (10) years of age or younger is not permitted in the dog play area.
- Any person eleven (11) to fifteen (15) years of age must be accompanied by a supervising adult.
- Any person in charge of a dog must be sixteen (16) years of age or older.
- Operating hours are from dawn to dusk. No dogs or persons are permitted in the dog play area outside of operating hours or if the play area is posted as closed.
- Dogs may not be left unattended in the dog play area at any time.
- A person bringing a dog to the play area must have a leash available at all times. All dogs must remain on a leash until they have fully entered the dog play area. Dogs must be placed on leash before exiting the dog play area.
- Notwithstanding the fact that dogs may be off leash inside the dog play area, a dog must be under the control of the person in charge of the dog at all times.
- Excrement must be promptly collected and removed, and may be placed in the trash bins only if contained in a closed plastic bag or other closed or airtight nonporous container. Failure to clean up after your dog or dispose of trash will result in a fine.
- The person in charge of the dog is responsible for any damage to the play area and surrounding property caused by the dog, including without limitation damage to any shrubbery, plants, flowers, grass, lawn, or fences. Holes dug by a dog must be filled in and any damage to surrounding property must be repaired.
- The person in charge of a dog is responsible for any injury to any person or other dog caused by that person's dog.
- Any person engaging in any activity assumes all risks associated with such activity and is liable for any damage or injury caused by said activity.
- The foregoing rules and regulations do not limit any applicable Denver Animal Ordinances, which shall continue to apply within the dog play area.
