Suggestions from Public Speakers and Dog Owners to PARC Commissioners

Because of your outreach, residents living near Lincoln, McKenzie, and Grant Park are uniting to develop common solutions that other dog owners and residents want or will more universally support. I hope to create a petition for these ideas with at least 100 signatures by January 24.

We feel the current workshop approach is less likely to produce a good outcome than it could because it is limited to four options – two of which will certainly be strongly opposed by residents and ultimately be rejected by Council. We dislike the Charrette process as it stands (it is too limiting and does not involve residents sufficiently) and ask you to rethink the process.

Here are our 4 new ideas we ask be added to the workshops for residents to discuss:

- (1) Expand [add] a pilot program choice of off-leash locations from 2 parks to include most or every park [especially Grant, Marymead, Redwood Grove, and Rosita] as an option to the council mandate. This approach could gather more information quickly and allow more people to walk to the park of their choice. It is easier to terminate a location than to add them later. Witness the Grant Park Senior Center pilot program has not expanded beyond one day a week over 4 years afterward. Why not provide this option to the council along with the mandated 4 locations if there is enough public support that we expect?
- (2) Locate a dedicated fenced dog park at the unused land at Heritage Oaks Park instead of McKenzie and Lincoln or at places noted in option (4). Although we do want any we can live with them providing they do not take away universally shared play areas in existing parks. Any fenced dog park should have artificial grass [weekly power wash] or aggregate.
- (3) Adding a 100% fenced park option with off-leash hours could be better than a dedicated fenced dog park because it preserves play areas in existing parks and would not need artificial grass or aggregate. Why not try this at either the already fenced Little League field or add fences at other parks like Grant or Lincoln or Marymead? If the council chooses the limited mandate solution we would then wind up with Heritage, Lincoln, McKenzie, and the Little League the equivalent of having 4 off-leash and 4 non dedicated fenced dog parks instead.
- (4) Create a new dedicated fenced dog park at the Woodland Library [it is subject to flooding] or use the corner lot at Fremont-Grant instead of McKenzie or Lincoln. One Woodland Library neighbor I spoke with likes this idea and I will talk to others.

We need morning time for dog exercise and afternoon time for socialization. We want off-leash hours from sunrise to 9 or 10 am and from 4 pm to sunset or 4 to 6 pm.

Any dedicated dog park must meet ADA requirements that as a minimum require complete fencing with double gated entries. Not sure about off-leash parks but doubt it.

In summary, please add these ideas to the four on the table and also include the option of none of the above for off-leash ours and fenced dog parks as well.

I am writing to strongly oppose the proposal for a fenced-in dog park in South Lincoln Park. I walk on the Lincoln Park sidewalk once or twice a day and have the following concerns about a dog park:

- The noise. I listen to an audible book when I am walking in the park. I would not be able to hear my book over the sound of dogs barking. The churches and the organizations that meet at the three churches just off the park would be impacted by the noise, likely to the point that the lovely choir practices we often hear would be disrupted.
- The division of dogs/owners and other people. We currently enjoy this park as a place to meet our neighbors and stop and chat, with and without dogs. A fence would leave less room for neighbors and create an unneeded barrier.
- Cleanliness/eyesore. I am concerned that there would be a lot of dog poop that would not be picked up.
- Attracting a lot of non-neighbors to our neighborhood. A dog park would serve people outside the neighborhood, bringing more traffic and noise to the area, thus compromising the neighborhood feel of this beautiful local open space. One of the best facets of our neighborhood is that we meet our neighbors on the road to downtown Los Altos. We have been encouraged to walk to downtown rather than drive because the parking is very limited. It will be less attractive to do so if we feel the park has been invaded by people who do not live near here and do not have an investment in our neighborhood.

I would ask whose needs would be served by a fenced-in dog park? Not mine, not our local neighborhood. Whose concerns are driving this proposal and what is their motivation? Why has there been so little outreach to the surrounding community?

I strongly oppose the dog park. Please respond to my concerns.

SUBJECT:

Pilot Off-Leash Hours and Fenced-in Dog Park Update

RECOMMENDATION:

Receive updated joint report from City staff and Subcommittee regarding proposed pilot program for off-leash hours and fenced-in dog park. Review workshop format and public outreach efforts.

BACKGROUND

At its regular Parks and Recreation Commission (PARC) meeting of August 14, 2019, Vice Chair Stuart Eckmann and Commissioner Scott Spielman volunteered and were appointed to serve on the Off-Leash Areas and Fenced-in Dog Park Subcommittee (Subcommittee).

The Subcommittee has worked closely with staff to evaluate options and gather information for the reports that have been prepared for the October and November 2019 meetings. The following report is a joint effort.

Need for a Dog Park

According to USA Today, Los Altos and Palo Alto have many demographics in common. Each have two ZIP codes among the top 10 most expensive ZIP codes in the country. Mountain View, which is listed as the 18th most expensive ZIP in the country, also shares many things with Los Altos, including the Mountain View Los Altos School District. In addition, the communities are all "dog" cities. The City of Palo Alto has three fenced-in dog parks. The City of Mountain View has one fenced-in dog park at the entrance of Shoreline Park, at the corner of Shoreline Blvd and North Roads, as well as seven designated off-leash areas, with additional ones planned. Los Altos residents would also like a dog park.

In a recent survey conducted by the City of Los Altos in spring 2018, 78.1% of those residents participating said they would like a fenced-in dog park in Los Altos. According to the City of Palo Alto, the level of interest is backed up by hard numbers: a Palo Alto animal control officer estimates that there are 3800 active dog licenses in Los Altos - approximately 35% of all households in Los Altos have a dog. The prominence of pets is reinforced by the fact that one of the top ten businesses in Los Altos is a companion animal veterinary practice, which was revealed in the 2010 City of Los Altos Comprehensive Annual Financial Report. It is perceived that many Los Altos voters would benefit from a local dog park.

Dog Park Definitions

For the purpose of this report, the Staff and the Subcommittee have established the following definitions:

 Λ "fenced-in dog park" is defined as an enclosed and dedicated area, which is often divided into two separate areas, one for larger/more active dogs and the other for smaller, shyer dogs. Dogs run off-leash in these dog parks. Λ fenced-in dog park typically is open from sunrise to sunset.

An "off-leash area" is defined as unenclosed areas where dogs can run but the owner(s) must manage their dogs so that they do not go beyond the designated off-leash areas, unless they are leashed. Off-leash areas typically have specific hours in the morning and afternoon/evening.

Since July 2017, the various PARC and Dog Park Subcommittees have explored the feasibility of establishing off-leash areas as well as fenced-in dog parks in Los Altos. In recognition of work by past Subcommittee members, the current Subcommittee has built upon the work of Tanya Lindermeier, Mike Ellerin and Grace Lilygren. The PARC approved forwarding a recommendation for an off-leash area to City Council, at its regular meeting of July 11, 2018.

At its regular meeting of February 12, 2019, City Council directed staff to prepare a proposal for a City of Los Altos pilot off-leash areas program at no more than two parks, and for staff to work with PARC to recommend a fenced-in dog park.

Per the approved minutes, City Council direction was as follows:

<u>Direction:</u> The Council directed staff to work with the Parks and Recreation Commission to fully develop a pilot program proposal with an implementation plan to include offleash dog hours at one or two parks, with limited hours, a public noticing plan and educational signage. Concurrently, staff and the Parks and Recreation Commission shall further explore and develop a recommendation for a designated, fenced-in dog park. The proposal for the off-leash hours shall come back to Council for final review before implementation, along with the PARC recommendation for a fenced-in dog park.

Off-leash Hours Areas

At its special meeting of October 16, 2019, the PARC discussed establishing a twelve-month pilot program for off-leash areas at the Hillview Baseball Field (Attachment 1) and Heritage Oaks Park (Attachment 2). These sites and hours were discussed by the PARC. In addition, the PARC recommended that staff expand the off-leash hours. Due to an increase in programming, the availability of afternoon and evening access is limited. Updated since the November 13, 2019 PARC meeting, the Hillview Baseball Field and Heritage Oaks Park programed schedules have been taken

At its regular meeting on November 13, 2019, the PARC received public input from 11 residents in favor of the PARC and Subcommittee efforts. Specifically, the residents were interested in afternoon and evening access to the proposed off-leash areas. While the hours are limited, staff is recommending

Subcommittee Recommendation - Off-leash Pilot Hours

Given that parkland is so limited in the City, the Subcommittee recommends that the off-leash areas be considered as shared space, so that scheduled programs, unscheduled activities and dogs all can have access to these areas.

Hillview Baseball Field

If this site is to remain under consideration for off-leash purposes, then efforts need to be made by staff to make this viable. Hours and months of access need to be appreciably expanded. These efforts could include providing at least one hour of off leash time before sunset year-round (thereby allowing off-leash hours during baseball season after the games), installing a temporary or permanent fence at the southeast end of the field to create an area for dogs, and other accommodations staff could offer to enable this site to be viable.

Final Subcommittee Comments - Off-leash Hours

The above proposed pilot hours are an effort to make the program work for all interested parties. The willingness to share space and cooperate is necessary from everyone.

Should the Hillview Baseball Field not be expanded in hours and months, it is recommended that the PARC recommend exploring a second alternative site.

The Subcommittee acknowledges that the time schedule varies and is complex but is necessary to accommodate all parties.

While the Subcommittee recognizes the need for field maintenance, it recommends that City staff explore how the time can be limited to one month per year.

The Subcommittee recommends that promotion of the program emphasize that the Off-leash Hours is a pilot program. Therefore, dog owners are being asked to be responsible and pick up after their dogs and observe the hours of access. Otherwise, users could lose the privilege of having the Off-leash program at the end of the year's pilot program.

The Subcommittee notes that the off-leash sites identified by previous Subcommittees, offer limited and inconsistent times for dogs and views this as a start. The Subcommittee recommends that the PARC consider other park areas for future off-leash areas after the pilot program is complete.

Fenced-in Dog Park

While the PARC has determined that McKenzie Park (Attachment 3) is a feasible option to designate as a fenced-in dog park, the PARC supported the Subcommittee's recommendation to further work with staff and return at the November 13, 2019, PARC meeting with South Lincoln Park (Attachment 4) as a second alternative to be considered.

DISCUSSION

The cost to design and develop a dog park is earmarked for FY 20-21, in the amount of \$250,000. The funds will not be officially allocated until the project is approved by City Council. The source of funds is from Park in Lieu Funds. The Subcommittee is anticipating that the cost to design and develop McKenzie Park will be substantially more than South Lincoln Park.

The Subcommittee has made the following observations, related to the pros and cons of two, alternative fenced-in dog parks:

McKenzie Park

At its regular meeting of May 9, 2018, the PARC established dog park location criteria based on the 2012 Park Plan. PARC has identified a location which meets many of the criteria for a dog park. The location includes a portion of McKenzie Park that borders on Fremont Avenue and Altos Oak Drive. The site is approximately 7,700 square feet of usable space. The triangular footprint backs up to tennis courts on one side and commercial medical offices on the other side. Residential properties on one side are buffered by offices on both sides of Altos Oaks. Residential properties on the other side are buffered by Fremont and Foothill Expressway. Included in a 2015 Initial Study-Mitigated Negative Declaration for a dog park in the City of Beverly Hills, a noise mitigation study concluded that the change in noise level would be minimal. The Subcommittee suggests that the existing traffic is likely to contribute more noise than a dog park.

Pros

- No contiguous residential properties
- Driving access without the need to go on residential streets
- Adjacent parking (pending enforcement of parking regulations). The parking lot is currently being used by City employees working at the adjacent City maintenance yard; people

accessing the medical offices on Altos Oaks Avenues; and those using the two City tennis courts or playground at the east end of the park.

- The location is not currently being used for specific parks and recreation programs. As a result, no program would need to be terminated or relocated.
- There are restrooms serving on the other side of McKenzie Park serving both parts (east and west)
- The location is easily accessible to both north and south Los Altos residents via the City's main thoroughfares, without creating additional traffic on residential streets

Cons

- Parking regulations are currently not enforced. The Subcommittee has observed over time
 that this lot is usually at capacity or close to capacity. This may be a challenge but could be
 mitigated by changing or enforcing parking regulations. the Subcommittee will rely on City
 staff for a better understanding of what would be done to ensure adequate parking
- Substantial grading and drainage work are needed.
- Wide tree coverage, which may adversely impact the drying time in rainy weather, possibly creating a muddy environment
- Fencing complexity because of an irregular boundary

South Lincoln Park

The Subcommittee has identified a second location for consideration of a fenced-in dog park: the south end of Lincoln Park. This is a long, narrow area along Foothill Expressway, which is located between Foothill Expressway and Lincoln avenue. The footprint can support two areas for large/active dogs and smaller/shy dogs, either contiguously or close to each other. The long/narrow space would allow more running opportunities than the McKenzie Park configuration. There is ample parking immediately adjacent to park. The properties closest to the park, are churches, separated by Lincoln Avenue with angled parking on both sides. This location could accommodate a two-zone fenced-in dog park of up to approximately 21,000 square feet. There are no Parks and Recreation Department activities on this site, current or planned.

Pros

South Lincoln Park has some advantages over the McKenzie Park. These include:

- Adequate drainage
- · Comparatively fewer trees than the McKenzie Park
- Appears it may dry out quicker during rainy season
- Parking is more than ample during the week
- Proximity to downtown businesses and proximity to major expressway
- Public restrooms available nearby in Shoup Park

- Less grading and land preparation would be necessary compared to McKenzie Park
- As with McKenzie Park, any noise from a dog park is not likely to be greater than that already generated by traffic on Foothill Expressway

Cons

- Potential parking issues on Sunday, which could be easily addressed by coordinating with nearby churches and closing the dog park for Sunday services
- Public restrooms while close by still require a walk to Shoup Park, with a steep grade.

Other scenarios: off-leash areas and no areas for dogs

Off-leash areas are typically established in an existing park space and is shared with other activities with limited hours. In addition, when dog owners do not pick up after their dogs, it impacts the experience residents have during non-scheduled times of the off-leash hours. Many dog owners run their dogs off-leash in many of the City parks and on school fields. Having off-leash areas and/or a fenced-in dog park provides choices and the intended goal to reduce non-compliance with existing ordinances around leashed dogs in parks. Alternative off-leash areas and a dog park are anticipated to support enforcement of ordinances as well as reducing recurring costs associated to turf maintenance in other parks.

Programs

A fenced-in dog park offers the Los Altos community a *de facto* dog community center. Drawing from other city dog park programs, the City of los Altos can offer the following programs:

- Unstructured time: a chance for dogs to play, and an opportunity for owners to socialize
- Dog instruction: obedience, agility, conformation (dog showing), and puppy training classes, as well as testing for the Canine Good Citizen (CGC) designation. The Deep Peninsula Dog Training Club and the West Valley Dog Training Club have both offered well-attended classes in Mountain View
- A special needs meet-and-greet: program in Clifton neighborhood, Cincinnati, Ohio includes
 an all-inclusive opportunity for those with special needs to bring their dogs (emotional
 support and otherwise), meet with other families with similar needs, and socialize with
 others who want to join them. This is being done in other communities as a "pop-up park"
 concept that has been very well received. (Attachment 5).
- An animal shelter and rescue group meet-and-greet: where these groups would have the
 opportunity to introduce adoptable dogs to the community
- Provide those who do not have a dog in their family, an opportunity to visit, spend time in
 the dog park, and see if a dog is right for their family. If the City of Los Altos were to
 develop a fenced-in dog park and work out relationships with dog training clubs, as
 Mountain View has, it may be an opportunity to expand its programming under the aegis of
 such clubs, without additional programming costs

Design

The McKenzie Park location has a fence on one side for the tennis courts. The South Lincoln Park location has a fence separating it from Foothill Expressway. Buildout for both dog park sites would require:

- Fencing the rest of the perimeter
- Divider to define two separate areas, for large and small dogs. This would be more difficult at McKenzie Park
- Two double-gated "airlocks," that are self-closing for entrance and exit into each of the two
 areas
- Replacement of the surface with hardy grass varieties, such as Buffalo or Red Creeping grass, or a decomposed granite (DG) surface to deal with normal wear and tear
- Possible grading to ensure adequate runoff
- Benches in each section
- Plastic bag dispensers and waste containers (one dispenser already exists at the South Lincoln location)
- Additional handicapped parking spaces adjacent to the site
- A community bulletin board to post scheduled events, dog-related service
- Signage for the park's rules
- Water

Specific to McKenzie Park

- Additional landscaping for the border it shares with the Altos Oaks properties
- · Removal of playground equipment and possible replacement with dog agility equipment
- Possible removal of some small trees and fencing around other larger trees

Samples of other dog parks and fencing are attached (Attachments 6 and 7).

Dog Park Rules and Signage (Attachment 8)

Many municipal dog parks are divided into two distinct areas for large dogs and small dogs. The Subcommittee recommends a division between large dogs and smaller or gentler/passive dogs because some older dogs, while large, may be more docile. Other posted rules include adult supervision, prohibiting supervision by individuals under a specific age. In addition, signs define the number of dogs allowed, pickup requirements, vaccination compliance, and dog park etiquette. No changes in our City code or ordinances would be required for a fenced-in or off-leash dog park. Ongoing Changes in the Community

Presented by the Subcommittee: Bay Area communities are facing housing challenges. The State of California is mandating additional housing units, and the City of Los Altos is addressing this with Accessory Dwelling Units and higher-density multifamily development whereby developers seek variances in allowable square footage and setback requirements. In 2019 dogs are, and will continue to be, part of the social and emotional fabric of families. The confluence of higher-density living, an overall decrease in per capita yard size, and the desire for families to include a companion animal, all work together to put pressure on our finite park space. It is expected that this trend will put greater pressure on the parks in the City of Los Altos. The Subcommittee recommends an extremely inclusive process to encourage residents to provide input and their views regarding a dog park. The survey and previous public input indicate that there is a consensus to support a dog park in various locations (Attachment 9). PARC and Subcommittee believe that providing 3,800 households or approximately 1 dog owner for every 2 square feet of park space is a useful and reasonable metric for any cost/benefit analysis park use for a dog park.

ADA Considerations

The City of Los Altos is required to meet the standards for accessibility in public facility design in accordance with the Americans with Disabilities Act (ADA).

Recommendation

At a special meeting on November 25, 2019, the PARC recommended that the "Pilot Off-Leash Hours and Fenced-in Dog Park Update" be scheduled at the next regular meeting on December 11, 2019, at 7 pm. In addition, the PARC scheduled the following two public workshops, with one to be held in the north and one in the south of Los Altos:

Wednesday, January 8, 2020 at 7 pm Saturday, January 11, 2020 at 10 am

The workshops are intended to be interactive and will be promoted and designed to solicit input from neighbors, dog owners and the general public regarding the off-leash hours and dog park proposals. The PARC scheduled a special meeting on Monday, January 13, 2020, to discuss a final recommendation for City Council, related to the proposed fenced-in dog parks and pilot off-leash hours.

The recommendation for the PARC is to receive updated joint report from City staff and Subcommittee regarding proposed pilot program for off-leash hours and fenced-in dog park. Review workshop format and public outreach efforts.

Subcommittee Recommendation

The Subcommittee recommends that the PARC consider including both South Lincoln Park and McKenzie Park as alternative sites for the public to consider for the development of a dedicated fenced-in dog park at a public workshop to receive resident comments, with the intent of

forwarding this on to City Council for their consideration and approval. The Subcommittee further recommends that the PARC approve the inclusion of this report, as documentation of a thorough process and recommendation for alternatives sites with a site of choice, to City Council for their consideration and approval. The Subcommittee supports the previous PARC recommendation for two off-leash sites with slightly differently time recommendations from staff, including the annual maintenance closure be limited to one month per year, per location.

A series of upcoming meetings could determine the fate of proposed fenced-in dogs and off-leash hours at Los Altos parks.

After lengthy discussion over format and the best options for gathering input, members of the city's Parks and Recreation Commission signed off on four public workshops at their Jan. 8 meeting.

The one-hour workshops are scheduled 7-8 p.m. and 8-9 p.m. Feb. 12 in the Garden House at Shoup Park, 400 University Ave.; and 10-11 a.m. and 11 a.m. to noon Feb. 29 in the multipurpose room at Grant Park, 1575 Holt Ave.

Based on commissioners' input, the workshops will include a presentation on the history, process, criteria and pros and cons of each proposed dogpark location. Copies of staff reports will be available for review, along with displays of the proposed sites. Attendees will have opportunities to provide additional, anonymous comments.

Fenced-in dog parks have been discussed for McKenzie and south Lincoln parks. Off-leash hours have been considered at Hillview Baseball Field and Heritage Oaks Park.

Catherine Stansbury, a leading proponent of a fenced-in park at Lincoln, has scheduled a meet-and-greet event noon to 4 p.m. Saturday (Jan. 25) at the proposed site to discuss her plans and solicit support.



Dear Ms. Legge,

I write to express my dismay at the idea of placing a dog park in South Lincoln Park. As a resident of 16+ years just south of the park, my wife and I usually elect to walk downtown to shop at Safeway or De Maritini's, among other stores, both for the exercise and to pollute less. Walking past a dedicated dog park (there are anyway dogs in Lincoln Park), would be an unfriendly, possibly dangerous and unsanitary experience, and it would effectively eliminate that stretch of sidewalk for us, as it would for families with children, and possibly even neighborhood dog owners.

Because of the park's proximity to Foothill Expressway, the park would be used to capacity by non-residents and would become congested and dirty. A serene green space would quickly become a segregated and noisy lot, and church and scouting activities, as well as weddings, etc. would be negatively impacted. The parking area and dog run would become an area that no locals would want to pass through. We already deal with beer bottles, smoking paraphernalia and trash behind our house on Palm Avenue. This would only get worse.

We all pay taxes in Los Alto to live in a neighborhood notable for good schools, safe streets, and attractive open spaces. A dog park in South Lincoln Park would truly ruin the oldest neighborhood in Los Altos (and it is worth noting that an idea like this would never be proposed, nor stand a chance, for North Lincoln Park, although it is a wider green strip and would impact far fewer residents and no local churches).

Finally, I feel that this is a hostile move against a charming old quarter of Los Altos, which would force many families to bypass the area by car, or detour around it on foot. It will negatively affect property values for blocks around, and the effects would spill into the entire community. This is an idea that does not benefit Los Altos.





City Considering South Lincoln Park for Fenced-in Dog Park Frequently Asked Questions

What's at issue?

The Parks and Recreation Commission (PARC) is preparing recommendations for City Council to implement two pilot programs for dog-owners: (1) off-leash hours at one or two parks and (2) fenced-in dog parks at one or two parks. The PARC is planning to conduct public workshops seeking input before finalizing their recommendations to City Council. At their Nov 11, 2019 meeting, PARC proposed recommending <u>fenced-in dog parks</u> at McKenzie Park and <u>South Lincoln Park</u> and off-leash pilot programs for the Hillview Baseball Field and Heritage Oaks Park. If approved as proposed, the South Lincoln Park enclosure would be a 21,000 square foot fenced-in dog park would be installed in the grassy area along Lincoln Ave between University Ave and past Orange Ave A fenced-in dog park would be reserved for dogs and their owners - it ceases to be available for use by the general public.

I hear an online survey was taken and Lincoln Park was one of the desired locations?

A PARC online survey was conducted from Jan-Mar 2018. Unfortunately, there were serious flaws with the survey's reliability. For example, anyone with an email address (or multiple email addresses) could submit a survey, regardless of whether they were a Los Altos resident, and online surveys could be submitted anonymously. It is known from public testimony that non-residents did submit online surveys. No one knows how much of the data from the 2018 survey is valid. A fair and effective survey submission should have included a location of residence the submitter along with the location of the nearest park to their residence. They should have asked "Are you in favor of off-leash hours in your neighborhood park?" And, "Are you in favor of a fenced-in dog park in your Neighborhood Park?"

How would this South Lincoln Park fenced-in dog park affect Old Los Altos Alley (OLAA) area?

A growing group of OLAA residents feel strongly that this proposed fenced-in dog park would very negatively affect the appearance of the area, resulting in a large and unsightly dirt and mud-filled enclosure immediately adjacent to the Foothill Expressway, gateway to our downtown. It would take this area away from everyone's free use of this area and cede it only for use by dog owners. A fenced-in dog park will change the existing physical nature and charm of Old Los Altos. This South Lincoln Park narrow strip of land along Lincoln Ave provides for open space for all citizens. It works in harmony with all visitors and neighbors. And this green belt is part of framing the city of Los Altos. Many dog parks are placed in industrial or less desirable locations because of their very nature.

How is a dog park a safety issue?

Some people think the idea of having a dog park sounds nice and not harmful, but the reality is: Dog parks are dirty and can carry disease. All major national dog associations recommend against owners taking their dogs to fenced-in dog parks, where the health, vaccination status and the personalities of the dogs and owners is not known. Protecting both the dogs and people using a fenced-in dog park is very difficult. This location is very close to the sidewalk and Foothill Expressway.

What about citizen welfare?

Old Los Altos Alley neighbors will experience the most negative impact? What about noise? What about all of the activities held at the three churches? How will this impact the Boy Scouts, two choir schools, Monday – Friday day school and after school programs, not to mention the services, weddings, funerals, meditation and prayer sessions. Dog-barking and people's voices carry and would be heard at the church locations. Who will mediate complaints?

How would traffic be affected?

The PARC report suggests and details that this site would be the hub for many dog related programs. Many people would begin to visit this site, many from outside the city thereby increasing traffic and adding to the already very difficult traffic flow at the Main/Foothill intersection. Not to mention the potential for overcrowding, and congestion due to events in Shoup Park and Redwood Grove.

But, what if I like the idea of a fenced-in dog park?

Tell the PARC that you want them to look for a site that is not part of the park system. Perhaps there is another city property that can provide for a dog park in a way that doesn't reduce our already-small open, landscaped park area. Perhaps PARC is having problems finding a suitable location because they have been directed to identify an existing park for a fenced-in dog park. Also, there are several public dog parks in the area: Los Altos Hills, Village Green near San Antonio Rd and El Camino, and others in Mtn. View.
















Fenced-In Dog Park in S. Lincoln: 18% Want, 79% Don't Want



Los Altos Fenced-In Dog Park

Why South Lincoln Park (SLP) is Unsuitable (From a Number of Residents)

The arguments against SLP as a dog park relate to its current appeal as an open, green space, how it would change, location concerns, potential hazards, and the loss of already meager park/green space in Los Altos.

In no particular order...

1. Loss of Park/Green space in Los Altos.

In comparison with many other communities in the Bay Area, the amount of park land and green space for use by residents in Los Altos is well below the norm. This fact was noted in the May 8, 2012, Los Altos Parks Plan. This plan compared Los Altos to 8 other similar, regional cities (San Carlos, Campbell, Burlingame, Cupertino, Mountain View, Palo Alto, Saratoga, and Menlo Park). In a Park Acreage Comparison table, Los Altos ranked the lowest of these cities (see page 4). The plan contains an assessment for why parks are important:

"Neighborhood parks serve as social and recreational focal points for neighborhoods. They provide greenspace ... and large grassy areas or fields that provide space for both active and passive recreation..." (See page 6).

The report further states that the city goals and recommendations "should be established to ensure future generations will be able to enjoy the use of the city parks for years to come. One goal should be to increase the amount of total parkland."

Building a fenced-in dog park at SLP would remove this space from what's available to the general public. We should not be contemplating actions that will diminish park acreage further. For this reason, removing greenspace to add a fenced-in dog park in any park in Los Altos does not make sense and is not in the best interest of Los Altos residents. Interestingly, this plan discussed what would be required for a fenced-in dog park and concluded that "None of the parks in Los Altos as presently constituted, meet all the criteria. As such, a site outside of the current park system that includes all of the above criteria should be identified before funds are allocated for a dog park." (See page 29). The plan ended with a recommendation to allow dogs on-leash in all City parks.

2. Location Concerns.

Established guidelines for locating dog parks indicate they should be buffered from residences and other public activities. This is because of noise, smells, unwelcome

interaction between dogs and residents, and other potential hazards. In the case of SLP, a public sidewalk, used by many people, including children and the elderly, on a daily basis, is located right next to the proposed dog park. There would be NO buffer between the public walking here and activities in the dog park. Clearly, many residents would be uncomfortable and intimidated taking walks along a sidewalk immediately adjacent to a dog park.

3. South Lincoln Park, the #1 Choice??

The claim that SLP was/is the #1 choice for a fenced-in dog park has been raised by a few individuals. This claim is not supported by verifiable facts. The Los Altos survey published in March 2018, for example, listed Lincoln Park as the top choice for a fenced-in dog park. However, the survey gives its location as "W. Edith & University Ave". This location is **North Lincoln Park**, not South Lincoln Park. North Lincoln Park is where the Los Altos Rotary Club's "Fine Art in the Park" is held every year. South Lincoln Park is greenspace on the other side of Main Street that is across from St. Nicholas Catholic Church. Placing a fenced-in dog park in North Lincoln Park would conflict with 4 decades of use by the Los Altos Rotary Club's "Fine Art in the Park." In fact, we understand that this along with other issues resulted in North Lincoln Park being removed from consideration as for a fenced-in dog park.

Approximately 20 months after the March 2018 survey, in November of 2019, South Lincoln Park mysteriously was elevated to the #1 choice even though it was not cited anywhere in the prior survey and was dismissed from consideration in a number of other prior PARC documents. For example, the May 9, 2018 PARC committee report entitled, "A Dog Park Committee report" states:

South Lincoln Park "would not provide the required 10,000 square feet of land without interfering with places of worship, bathrooms would be needed at great expense, Parking would be inadequate when nearby organizations were active, and errant balls and Frisbees would require golf range netting to guard against traffic disruption on the busy Foothill Expressway." (See Attachment A)

At the April 10, 2019 PARC meeting, in a report entitled "Dog Park Subcommittee Recommendation," the committee recommended McKenzie Park for a fenced-in dog park:

McKenzie Park "has more than adequate parking", has "easily-accessible rest rooms", and "is easily accessible to both North Los Altos and South Los Altos". (See Attachment A to Item 2)

This attachment also discusses a number of "alternative or additional locations" – neither North or South Lincoln Park is included among these. The last paragraph contains the following statement,

"The Dog Park Subcommittee is recommending the Parks and Recreation Commission approve the McKenzie Park site for forwarding on to City Council for their consideration and approval." (See Attachment A to Item 2)

After a number of PARC meetings and reports, dating from the March 2018 survey, where South Lincoln Park was either specifically cited as **inappropriate** as a fenced-in dog park site or simply not mentioned, the following statement appeared in the November 13, 2019 "Pilot Off-Leash Areas and Fenced-in Dog Park Proposal",

"The Subcommittee is recommending that the PARC consider including both South Lincoln Park and McKenzie Park as alternative sites for the public to consider for the development of a dedicated fenced-in dog park..."

No documentation is provided to explain how or why South Lincoln Park suddenly joined McKenzie Park to become one of the top two candidates for a fenced-in dog park despite numerous prior findings that Lincoln Park was not a suitable venue for a fenced-in dog park.

4. Potential Hazards.

The site of this proposed dog park is right next to Foothill Expressway, a busy commuter roadway where frequent gridlock occurs during commute hours every weekday of the year. A dog park bordering this busy thoroughfare would be a distraction to drivers and a clear hazard that could lead to even more accidents than what occur already.

Unless a very high (\approx 10-foot) fence is constructed along Foothill Expressway, balls and other dog toys accidentally tossed into traffic would be a certainty. And, a tall fence along this stretch of green space would be unsightly and detract from what is regarded by many as a gateway to downtown Los Altos.

5. The Ambiance of SLP.

Currently SLP is an attractive green space and gateway to Los Altos. It's seen and enjoyed by thousands of Los Altos and non-Los Altos residents every day while traveling along Foothill Expressway. Attractive, and highly-visible areas like SLP are part of what enhance the reputation of Los Altos and make it one of the most

sought-after places to live in the Bay Area. The importance of maintaining the appeal of SLP as a gateway to downtown Los Altos cannot be overstated. Indeed, the cover page of the 2012 Los Altos Parks Plan features a photo of Lincoln Park showcasing the beauty of this entryway to Los Altos.

6. How SLP will change.

Grass and fenced-in dog parks are mutually exclusive. The only way to fathom anyone promoting SLP as a dog park is to assume they simply don't believe this, yet, countless experts have confirmed it. I've spoken at a previous PARC meeting about what happened in Volunteer Park, a 48-acre, gorgeous park in Seattle, WA with which I'm very familiar. A fenced-in dog park was constructed in a grassy area of that park some years ago. After one or two seasons of use, the grass was transformed into dirt and mud and the impact of dog urine was threatening to kill a number of bordering, mature trees. The city of Seattle, after trying many measures to solve the problem, finally gave up, tore down the fencing, eliminated that dog park and returned the area to its previous condition.

"Cooperative Extension", a site offering advice from extension and university staff and other volunteers from a large number of land-grant institutions across the U.S., says this about grass at dog parks: "...there is nothing that grows that can withstand a constant input of dog urine. Copious amounts of water (will only) mitigate the problem..."

7. The Ambiance of SLP (continued)

If grass is not a realistic option for a dog park, then what is? Decomposed granite? Fines? Gravel? Wood chips? Each of these options have serious drawbacks, not the least of which is they're all ugly. Are any of these options what we want to present to our non-Los Altos neighbors along this gateway to Los Altos?

Some also mention the option of artificial turf. It can look good (at least initially) but it's not without drawbacks. It traps odors, fleas, etc., and needs ongoing washing and other maintenance. It's also very expensive. Installed cost is typically \$10/foot or more, so artificial turf alone would add \$\frac{1}{4}\$ M to the cost.

8. Lincoln Park neighborhood residents – including many dog owners – want to preserve Lincoln Park as it is.

As I believe you are aware, approximately 30 Lincoln Park neighbors gathered at Lincoln Park on January 25 from noon to 4 pm to express their objection to a fenced-in dog park and their explicit desire to preserve the green space at Lincoln Park. As our neighborhood has become aware of the possibility that green space could be

removed and replaced with a fenced-in dog park, signs stating opposition to this have begun to appear.

For the reasons stated above, I respectfully submit that Lincoln Park is not an appropriate venue for a fenced-in dog park.



Subject: Opposition to dog park in South Lincoln Park

It is my understanding that the dog park was defeated last year under the previous Commission. It now surfaces again. I am opposed to the redevelopment of South Lincoln Park for the purpose of a dog park for numerous reasons including the following:

- 1. With ongoing redevelopment in the village of Los Altos we have seen rise to multistoried condominiums and commercial properties, shaded daylight, blocked air flow, parking needs, quest for incorporating green space, pop-up parks...... We have little undeveloped land and real estate is at a premium. Identifying space for a dog park is problematic. When green space is sought after within the village, why would we eliminate established green space bordering the entrance to our village?
- 2. Rest rooms at Shoup Park have been suggested for use by visitors to the dog park. The distance between the two parks makes this idea unrealistic. Three churches and The Chamber of Commerce are closer. I believe these would be explored for use by the public and that the intrusion would not be welcomed. If indeed a "de facto dog community center" develops as suggested, there would be additional increased need for rest rooms. Solutions to this realistic demand would come at a price,
- 3. I have heard that a driving force behind the development of a dog park is an individual who does not live in Los Altos or pay local taxes. If this is the case, what is this person's interest or connection to our community? Could you please address this issue.

- 4. Los Altos summers are hot. One could once refresh in the city pool at Covington which succumbed to redevelopment. Now redevelopment ideas suggest replacing a green space with a fenced in dog park where urine and feces and flies are inherent and it is particularly problematic in the heat of the summer. A dog park on this narrow strip of land in direct proximity to residents, the public walkway, three churches and the entrance to the village of Los Altos does not make sense. The existing park land already provides green space that Los Altos is seeking to increase in the village as stated above.
- 5. How is South Lincoln Park to be impacted if the number of traffic lanes on Foothill is increased to accommodate today's traffic flow? Realizing this could have impact on redevelopment of the green space.

Subject: Feb 3, 2020 PARC Meeting, Agenda Item #3, Dog Workshop Planning

I have lived in the Lincoln Park neighborhood on University Avenue for 36 years. I have owned many dogs during my childhood and as an adult, including dogs while living here, although we currently do not own a dog. My intent is to provide ideas and suggestions for the structure and process for the planned workshops that will benefit everyone by obtaining resident feedback with a process that is fair, unbiased and produces useful and valid input from the residents of Los Altos. With that intent, I recommend the following:

- 1. The history of what led up to these workshops should be kept to a minimum and presented by one individual from PARC or staff; the emphasis should be to describe what is being considered, clarify any misunderstandings about the proposals, and then seek resident input through voting and comment cards; it is sufficient history to say that City Council, at their Feb 12, 2019 meeting following a presentation from PARC and staff about the ideas for off-leash and fenced-in pilot projects asked PARC and staff to go back and further study and develop their recommendations and come back to Council with a specific proposal for pilot programs for one or two parks; that's all that really needs to be said 5 minutes
- 2. Just as we do with voter ballot measures, there should be a timed (or word-limited) opportunity to present pros and cons (for and against) off-leash hours and fenced-in dog park in Los Altos, just as we do with voter ballot measures; these written for and against statements could be prepared by PARC and staff based on the ample written record to date or written by advocates and opponents and vetted by PARC and staff 5 minutes each
- 3. While the city may welcome anyone to attend these workshops, any speakers addressing the workshop attendees should be limited to city staff, PARC members and Los Altos residents; all attendees should sign in with their name, address, and a contact method (email, phone) to allow for PARC and staff followup questions to them; only Los Altos residents should be provided any voting methods; a voter ballot card would be the preferred method, not stickers, in order to avoid visual bias from stickers on maps; during sign-in, Los Altos residents should be verified by photo ID/utility bill before providing them with a numbered ballot card, corresponding to the registration list number; this would assist in a more complete, effective and fair interpretation of the results and would avoid any perceptions about voting bias
- 4. I believe that the intent of having a "fishbowl" for any additional input or comments from attendees is a good concept, and it should be organized to be able to obtain and use the feedback effectively and fairly; I assume that the intent of the fishbowl is to capture valuable feedback from the community that the Commission may not have considered in the spirit of having all voices in the community heard; I would recommend that for this input to be fair, effective and useful for PARC following the workshops, you should consider providing a prepared form for this purpose, possibly a pre-printed postcard format that asks for name, address and contact information; you may get feedback without that information, but it would be most useful to the city and to PARC to have it in order to follow up. PARC should also consider limiting the number of cards per individual -- how about two?

SUBJECT: SAFETY ISSUES RELATED TO PARC REPORT RECOMMENDING DOG ACTIVITIES AT S. LINCOLN PARK

I want to highlight safety. Safety related to dogs, people and the environment. A statement in the PARC report, which suggests, "A fenced in Dog Park offers the Los Altos community a de factor community center drawing from other city dog park programs, the City of Los Altos can offer the following programs..." I strongly disagree with this statement as it relates to Lincoln Park. I do not want to see a "defacto community center for dogs" at Lincoln Park. This recommendation would encourage a large number of people to this small, limited resources area that I believe cannot accommodate this amount of activity and thereby creating safety issues.

Human Safety. If this fenced-in dog area is developed in Lincoln Park, I ask you to imagine what it would entail? Dog parks, I so understand, are enjoyed by many dogs and their people when the park is not crowded. If the number of dogs and people are not managed you might see more car accidents, dog bites, arguments among people related to parking, noise, and just general bad behavior. I have recently witnessed this in a San Carlos dog park. It was crowded with people and dogs, and one dog started a fight with a pack of dogs and the people were not happy. Most everyone left the park but not without shouting at each other. The man whose dog started it all – ran out quickly. It was a mess. Also, age requirements need to be examined, and people should know that they are personally and legally responsible for their dogs. Another avenue worthy of exploring is the opinion of the maintenance workers. What do they think about cleaning/maintaining a dog park? Do they feel their health is a risk?

<u>Dog Safety.</u> Much has been reported and supported by dog associations and veterinarians against taking dogs to fenced-in dog parks. How many dog owners know that vaccinations, fights, diseases are a potential threat to health of dogs? It's

recommended to clean a dog's paws when leaving the park to minimize the risk of parasites or diseases from the soil. Also, dogs should not share water resources. I suggest that people observe a crowded, limited space dog park and decide for themselves if this is a safe place for their dog. If a dog park were built within Lincoln Park, I would think that it would be crowded most of the time because of its location and the associated activities mentioned in the PARC report.

Environment Safety. How will a dog park fit in with the grass, trees and art already in this beautiful, small stretch of land? Would trees be removed? Earth rearranged? What about the wild life so close by? What about the traffic delays on Lincoln Ave. and the already congested intersections a Foothill expressway.
