SUBJECT: Parks and Recreation Commission Work Plan Update

RECOMMENDATION:

Review FY 2020-21 Work Plan, Update and Approve Commission Corrigan Assignments

BACKGROUND AND DISCUSSION

Annually, City Council hosts a joint meeting with a group of appointed commissions to review and discuss each commission Work Plan, including past accomplishments and recommended projects for the next year. The Work Plan guides the work of the Commission for the term year. For the Parks and Recreation Commission (PARC) the terms are staggered amongst the seven members and expire on March 30, following the completion of a four-year term.


Should the PARC have anticipated vacancies, the City Clerk facilitates a recruitment and screening process with the City Council, to fill the vacancies by March. The PARC reorganizes and selects a new Chair and Vice Chair during the month of April. Traditionally, the City Clerk schedules an annual joint meeting with City Council in May. The PARC term year is March to March.

At a Special Meeting on April 22, 2020, the PARC revised its FY 2020-21 Work Plan including goals, projects, assigned commissioners, target dates, associated City priority, and status. The PARC Work Plan was reviewed and discussed at a joint meeting with City Council on May 5, 2020.

As the PARC proposes new projects, staff updates the Work Plan. Staff is recommending that the PARC review the current Work Plan due to the following impacts:

- Recent appointment of Commission Corrigan
- Anticipated vacancy of Commission Weinberg moving to City Council in December
- Anticipated appointment of new Commissioner
- COVID-19 Pandemic suspended and limited in-person offerings per Orders

Staff has attached a revised Work Plan that reflects those areas that Commissioner Corrigan is interested in, including those areas that are currently assigned to Commissioner Weinberg. While some projects have the maximum number of commissioners assigned, Commissioner

Corrigan's name is shown in the event commissioners may want to switch assignments. In addition, staff is recommending that the PARC consider modifying the Work Plan due to COVID-19.
