Approve: Lindermeier, Spielman, Dailey, Yeh, Corrigan, and Morris. Oppose: None. Abstention: None. Motion passed unanimously: 6-0-0.

2. Complete Streets Master Plan Project - Task Force Invitation

Receive updated on the Complete Streets Master Plan (CSMP) project and consider assignment of a Parks & Recreation Commissioner to the CSMP Task Force

Public Comment: None

<u>Action</u>: Commissioner Dailey made a motion to nominate Commissioner Morris to the SCMP Task Force. The motion was seconded by Chair Lindermeier. Approve. Spielman, Dailey, Yeh, Corrigan, Morris, and Lindermeier. Oppose: None. Abstention: None. Motion passed unanimously: 6-0-0.

3. Equal Access to Public Places and Recreation Opportunities Resolution

Discuss resolution options and forward a recommendation to City Council

Public Comment: None

<u>Action</u>: Vice Chair Spielman made a motion stating that the Parks & Recreation Commission affirms City Council Resolution No. 2017-07, including a new section regarding equal access to our parks and recommends that City Council to forward its resolution to all other Commissions. The motion was seconded by Commissioner Corrigan.

A friendly amendment was made by Commissioner Dailey to include phrasing that began with "and recommends that City Council takes up Resolution 2017-07 again, reaffirming it, and as appropriate, including equity of access to our public places, and then promulgates it to every Commission," but the friendly amendment was not accepted by Vice Chair Spielman and Commission Corrigan.

Commissioner Dailey made a procedural objection, which was addressed by the following friendly amendments (which were made, discussed, and then approved by both Vice Chair Spielman and Commissioner Corrigan):

- A. Vice Chair Spielman removed the phrase "including a new section regarding equal access to our parks" from the motion.
- B. Commissioner Dailey requested to add the clause "and includes the Resolution in the Commissioner Orientation Packets moving forward" at the end of the motion.
- C. Vice Chair Spielman added the phrase "for all parks and recreation activities" following the full title of the City Council resolution.
- D. Commissioner Morris requested to replace the word "affirms" with the word "values."
- E. Chair Lindermeier requested to remove the other word "other" from the clause "all other Commissions."

The amended motion read as follows:

Vice Chair Spielman made a motion stating that the Parks & Recreation Commission values City Council Resolution 2017-07 for all parks and recreation activities and recommends that City Council forward its Resolution to all Commissions and includes the Resolution in the Commissioner Orientation Packets moving forward. Commissioner Corrigan seconded the full amended motion. Approve: Lindermeier, Spielman, Dailey, Yeh, Corrigan, and Morris. Oppose: None. Abstention: None. Motion passed unanimously: 6-0-0.
