# 4. Social Justice, Equity, Diversity, and Inclusion (J.E.D.I.) Resolution

Discuss proposed resolution by the Social J.E.D.I. Subcommittee and forward a recommendation to City Council

<u>Public Comment</u>: Roberta Phillips expressed that she does not believe that each of the lines written in the declaration are necessary. She specifically cited that if there is no data for a line (to back up the claims), the line in question should not be included in the resolution.

<u>Action</u>: Commissioner Dailey moved to take a straw poll to determine if the Commission would support the language of the proposed resolution as it was proposed, with the possibility for Staff and the City Attorney to make adjustments regarding word choice and in keeping with best practices. The motion was seconded by Commissioner Yeh.

Commissioner Morris made a friendly amendment to word the request for the straw poll to read as follows: do we [the J.E.D.I. Subcommittee] have support for this document [the J.E.D.I. Resolution] with room for discussion regarding the wording?

After discussion, the motion was not voted on.

<u>Action</u>: Commissioner Dailey moved that the document [resolution] be given to staff to check that the language/wording comports with best practices in this domain before bringing it back to the Parks & Recreation Commission for consideration. Commissioner Morris seconded the motion.
