We wish to thank you for the time and consideration, today, of Jeff Morris' application for a use permit for a proposed administrative office for the Heising-Simons Foundation in the vacant space on the ground level of the 400 Main Street building.

We apologize that we are not able to be here in person to support Mr. Morris' application, but wish to share these thoughts for consideration.

I know we speak for the entire staff of the Heising-Simons Foundation when we say how much we appreciate being part of this community. We have enjoyed building relationships in Los Altos—be it through Chamber of Commerce functions; through a relationship with the Los Altos Community Foundation; and through the daily interactions of being part of a vibrant downtown where our staff enjoy the restaurants and commerce.

The Heising-Simons Foundation is a growing foundation. Since its first grant in 2007, the Foundation has awarded more than \$263 million, most recently awarding more than \$54 million last year, and being well on our way to exceed that amount for the current year. Our support to nonprofits aims to unlock knowledge, opportunity, and possibilities in the areas of early childhood education, science, climate and clean energy, human rights, and local opportunities. This reflects our fundamentally optimistic view of the world, and our belief in the potential for improvement in the human condition. We feel incredibly fortunate to be able to fund thoughtful leaders and passionate nonprofits, and to have resources to support a quest for greater understanding and improvement to social and environmental problems. And we feel privileged to do this in, and be part of, Los Altos.

The Foundation currently has a staff of 30 people—with three new job openings posted this month—and resides on the second floor of 400 Main Street, in suite 200. As we continue to grow, we recognize that we will be limited in desk and meeting space in our beautiful offices in the coming years. Jeff Morris has been the most professional and supportive of landlords, and our space is one we do not wish to vacate. Thus, the prospect of being able to also use an adjacent space—one that greets us each morning as we climb the stairs to our office, and one that has been vacant for the entirety of our tenancy—is indeed a thrilling one.

The Foundation has increasingly become a destination for meetings with our peers, our grantees, and with issue experts brought in to advise us. We regularly hear how they appreciate coming to visit Los Altos, and the expanded space will not only allow our staff to grow but also enable us to continue this practice.

We wish to publicly thank you for this consideration, and to thank Mr. Morris for the strong role he plays in helping this community continue to be one in which we so enjoy participation.
