<u>Action</u>: Upon a motion by Vice Chair Chapman, seconded by Commissioner Ellickson, the Commission recommended the *Door Sculpture to Talk About the Idea of Different Possibilities You May Have to Process Your Life* be placed in Lincoln Park directly south of the Chamber of Commerce building by a 4-0-3 vote, with Commissioners Rini, Robinson and Zucker absent.

<u>Action</u>: Upon a motion by Chair McBirney, seconded by Commissioner Ellickson, the Commission recommended the City approach Passerelle Investment Company to contribute \$14,000, the City contribute \$7,000 and the community fund raise \$7,000 to fund the acquisition of the sculpture by a 4-0-3 vote, with Commissioners Rini, Robinson and Zucker absent.

7. <u>2014 City Council meeting representatives</u> Commissioners discussed the 2014 City Council meeting schedule and began assigning representatives to those meetings.
