
BACKGROUND

BACKGROUND

The City of Los Altos Artwork Donation Policy is intended to establish a process for the donation of artwork to the City.

DISCUSSION

The City has received an offer to donate a sculpture by artist Jeff Owen entitled *Excite*. The sculpture is currently owned by George Prodan, a Los Altos resident, who has offered the donation.

Per the Artwork Donation Policy, the Public Arts Commission (PAC) is to review the proposal on the "basis of aesthetic quality, relationship of the artist or artwork to the City of Los Altos, site availability, condition of the artwork, and installation and maintenance requirements." Based on the review, the PAC will then present the artwork to the City Council for acceptance or rejection.
