Anabel Pelham, PhD of Age Friendly Programming gave a presentation on Age Friendly Community Sustainability Principles GIA. Formed a relationship with the California AARP who oversees the next steps to create an action plan over 5 years.

Cheri Anderson, 50+ Coordinator: Discussed and detailed the social and physical programs at the Los Altos 50+ Center and Grant Park.

Commissioner Basiji: Wants to know what the next steps are and suggests creating a sub-commission with Commissioners Buchholz and Li that will meet with Anabel Pelham after her arrival on July 5 to provide a thoughtful but not massive, strategic, targeted look at current unmet needs especially with COVID-19. Los Altos is 3 years behind but wants to conduct focus groups of 12-15 people (vs a survey) and work directly with a task force.

Commissioner Cohen: Quantitative data existing in county and city and will help write up an action plan.
