1. Item 1: Commission Minutes  
Action: Upon a motion by Commissioner Erogbogbo, seconded by Commissioner Rajagopalan, the Commission unanimously approved the minutes of the meeting of June 3, 2019.

Action: Commissioners unanimously voted to co-host the Teen Movie Night in LAH and created a subcommittee (Vice Chair Erogbogbo, Commissioner Harpaz, Rajagopalan, and Hong) to work with LAHYC.
5. Item 5: Review Work Plan  
Commissioners reviewed and discussed the current work plan.  
Action: This item was continued to the next meeting.
6. Item 6: Youth Ambassador Group

Commissioners discussed logistics and expectations of the Ambassador Group.

Action: This item was continued to the next meeting.

Staff proposed the idea of having the Youth Commissioners host an activity before the Halloween Movie Night on October 19. Commissioners discussed possible activities.
