Mr. Erogbogbo also updated the Commission members on the status of the Resource Officer program at Los Altos schools. City Council member Fligor provided further details on that program.
9. Publicity Subcommittee: Commissioner Sander reported on the subcommittee's projects, including completion of the subcommittee's work plan and creation of a flier for the Youth Ambassador program. A request was made to Staff Liaison Wells regarding the City's email list as well as rules for publishing on social media. Mr. Wells will report back with findings.
10. Special Events Subcommittee: Commissioner Morokutti reported on the subcommittee's plans and ideas, including the idea of costumed character visits to seniors and a toy drive. Chair Erogbogbo requested weekly updates from the subcommittee.
11. YAC Social Subcommittee: Staff Liaison Wells thanked the participants, requested and received their comments.
