DISCUSSION ITEMS

1. Minutes from the April 23, 2012 regular Historical Commission meeting

MOTION BY COMMISSIONER BAKER SECONDED BY VICE CHAIR WELSH, to approve Meeting Minutes.

2. <u>482 University Avenue – Halsey House</u>

The Commission discussed the care taker's unit. Commissioner AHMADJIAN-BAER noted that the unit did not appear to have the necessary historic integrity to get designated and that the focus should be on preserving the Halsey House. Commissioner BISHOP noted that the care taker's unit contributed to the historic setting/context of Redwood Grove and that it could have the necessary historic significance to be designated as a historic resource.

The Commission noted that a clearer history of the care taker's unit and its relationship to the Halsey House was needed before action could be taken.

Commissioners BISHOP and WELSH provided a report on the communications with the Steve Jobs movie crew, the History Museum and their upcoming expo on Entrepreneurs of Silicon Valley, and of the Steve Jobs artifacts that are archived at Stanford.
